ABOUTMessage from our Executive**Director and Board ofDirectors Chair**

Nassau Suffolk Law Services (NSLS) has been a dedicated provider of civil legal services for nearly 60 years and presently stands as one of the largest providers of free legal assistance in the State of New York. As we reflect on our continuous commitment, we acknowledge the strength of our staff and supporters, especially in the wake of these unprecedented times.

The year 2022 marked the start of a new beginning as we continue to work our way out of the COVID-19 pandemic. Our legislators have played an imperative role in setting a new standard by increasing our funding, leading to the growth of several service areas including eviction and consumer debt.

Throughout 2022 we worked to reestablish links to the community that were lost during the pandemic, as so many services our clients relied on shifted their delivery models in response to the pandemic.

Within our organization, the Housing/Eviction Defense unit has seen the most significant increase in size. Issues relating to eviction prevention, Section 8, and topics relating to public housing are tackled by our incredible team. Our top priority is to elevate support to these areas and pave the way for housing stability.

As the eviction moratorium ended on January 15, 2022, we were eager to step back into the courts and provide representation to tenants involved in eviction cases throughout Long Island. With additional funding from the New York State Governor and Legislature, we were able to expand our eviction prevention staff, provide more services in the courthouse, and shift our attention toward rural and less populated geographic areas, such as the east end of Long Island.

NSLS also proactively connected with the community by prioritizing outreach events and focusing on collaborations that strengthened the services we provide.

The exceptional dedication of our staff, volunteers, partners, and donors directly reflects our willingness to face any challenge at hand. Our ability to advocate for clients remains strong thanks to their support.

As we shift our focus toward the future, our aim is to maintain an ongoing commitment to our mission and adhere to our legal values as we strive to create a just world.

OUR PROGRAMS

Adult Care Facility Project

assists residents of adult care facilities in matters related to finances, facility conditions, and treatment of residents.

Civil Unit

helps tenants with housing issues, including eviction proceedings and federal rent subsidy issues.

Civil Rights Project

helps people reintegrate into the community after facing criminal charges by helping them to address criminal history-related civil legal issues. In addition, the project assists transgender, nonconforming, non-binary lowincome people overcome the hurdle or name/sex designation changes, housing and employment discrimination, or denial of benefits.

Community Legal Help Project

partnership of legal services providers to provide legal information, referrals, and limitedscope representation to Nassau and Suffolk County residents at public libraries or community centers.

Consumer Debt Legal Project

helps people with consumer debt legal issues, e.g. medical & credit card debt.

Disability Advocacy Project

assists with appealing Supplemental Security Income (SSI) and Social Security Disability (SSD) application denials.



Domestic Violence Project

helps Suffolk County survivors of domestic violence in family law matters, including obtaining orders of protection and custody.

Education and Disability Rights Project

provides legal assistance to students with disabilities and adults with developmental disabilities who are seeking eligibility and services from the Office for People with Developmental Disabilities (OPWDD).

Education Debt Consumer Assistance Program

provides legal assistance to people who are experiencing student debt problems, including unpaid tuition bills, collection actions, and managing federal and private student loans.

Child Support Defense Project

represents non-custodial parents in child support downward modifications and add-ons for arrears (Suffolk County only).

Foreclosure Prevention Unit

works with homeowners to avoid foreclosure and preserve their homes.

HIV/AIDS Project

assists people living with HIV and their families on issues affecting public benefits, housing and health care, and with planning for the future through wills, guardianships and advance directives.

Independent Consumer Advocacy Network (ICAN)

provides education, information, and advocacy for participants and caregivers in Medicaid managed care and Medicare long-term care programs.

Legal Support Center for Advocates

serves as a legal center for advocates from social service agencies, religious organizations, health care facilities, and other community-based agencies.

Mental Health Law Project

provides legal assistance in civil matters to persons who are severely and persistently mentally ill. This project focuses primarily on issues such as housing, public benefits, health care, and child support.

Public Benefits Unit

supports the integrity, safety, and well-being of low-income families by maintaining economic stability.

Senior Citizen Law Project

provides legal representation, advice, and referrals to residents of Nassau County aged 60+ in matters relating to health care, housing, Social Security, and future planning.

Social Work Unit

helps our most vulnerable clients complete tasks necessary for successful outcomes to their legal cases and address social issues that may be impeding the resolution of their legal issues.

Veterans' Rights Project

helps veterans with obtaining veterans' benefits, discharge upgrades, public benefits, landlord/tenant, and family law matters.

Volunteer Lawyer's Project/ Suffolk Pro Bono Project

recruits private attorneys to represent people with low incomes without charge. Our volunteer attorneys handle cases ranging from bankruptcies and guardianships, matrimonial matters and wills.

Richard's Story

Richard has worked as a maintenance man for several years through the Corporate Source, a non-profit organization dedicated to providing employment to individuals with disabilities, as well as services to foster their independence. When he first came to Nassau Suffolk Law Services for help, he felt uncomfortable and anxious about a situation that one of his close friends and coworkers put him through. Last year, his friend asked him to cosign a loan for a new car, and he agreed. However, what started as an attempt to help a friend in need soon took a turn for the worse.

"When my friend had the car under his name, he called me and told me he was making the payments on the car at the time. A few days later, he told me he passed the car on to someone else," Richard said. "That other person was supposed to make the payments and maintain the car, but she wasn't doing it either."

A few months later, Richard discovered that the person in charge of the car's maintenance and payments abandoned the car somewhere in New York City, and that he owed about \$11,000 in payments to the lender, which he could not afford. Unsure about what to do, Richard went to his case manager – Jeremy Burwell – from the Corporate Source for help.

An Advocate's Perspective

Jeremy, a manager of vocational rehabilitation services at The Corporate Source, has worked with Richard for over five years, aiding with Richard's employment and Social Security Disability income. After a conversation with Richard, it became clear that he was not going to meet the bank's demands and that he would need some professional legal assistance. After doing research, Jeremy decided to contact Nassau Suffolk Law Services for help.

An Attorney's Perspective

When Helen Wrobel, staff attorney in the Consumer Debt Project, took over the case, Richard had already attended his first court appearance. During the following court appearances and legal processes, Helen worked together with Richard and Jeremy with one goal in mind – to keep the case from going to trial or arbitration, or anything where a judge or an arbitrator would render a decision.

"I began trying to show them that this was totally wrong," Helen said. "Even if they were right on the law, they were wrong on the moral equation that Richard, a person who has disabilities, was coerced or fooled or duped into becoming a cosigner of the loan."

Over the course of the case, Helen worked with Richard and with Jeremy to push for a discontinuance. She gathered documents from Richard showing that he receives disability income and how he is an individual with disabilities; she sent it over to the plaintiff to convince them to discontinue the matter, which, ultimately, they did.



COLLABORATIONS



Senior Citizen Law Project

NSLS is a member of Nassau County's Enhanced Multidisciplinary Team (E-MDT), which addresses all forms of elder abuse – financial exploitation, physical abuse, psychological abuse, sexual abuse and neglect by others. The E-MDT, which is funded through OVS/VOCA and meets on a monthly basis, brings together entities with unique resources and skills to provide improved and effective cross-systems collaboration and specialized responses, resulting in restored safety and security to older adults on Long Island. We have partnered with Family and Children's Association to provide an elder law attorney to attend the meetings, review and provide consultation on cases that are brought to the team's attention. NSLS also provides legal representation where appropriate.

EDRP Collaboration


NSLS's Education and Disability Rights Project (EDRP) has developed a partnership with the Women's Opportunity Rehabilitation Center, Inc. (WORC), located in Hempstead, New York, to assist girls under 17 years old who live in that community and who are at risk of involvement and/or are involved in the juvenile justice system. The program, which is funded by the Office of Juvenile Justice and Delinquency Prevention (OJJDP) is designed to "reduce risk factors and promote protective factors for girls who come in contact with the juvenile justice system, and place them on a path toward success, stability and long-term contribution to society." EDRP will provide: 1) advice and counsel to the students in the program regarding general education issues; and 2) advocacy to qualified students in the area of special education.

Domestic Violence Subcontracting

Nassau Suffolk Law Services contracts with The Retreat, Inc and Brighter Tomorrows to represent victims of Domestic Violence in Suffolk Family Courts in Central Islip and Riverhead. Clients are served through our Domestic Violence Unit (DV unit) and are assisted in obtaining Orders of Protection, Support and Custody. The DV unit also handles paternity matters as well as abuse and neglect cases brought by Child Protective Services in Family Court. The attorneys and paralegal in the unit work closely with advocates in the respective agencies to bring a fair and just outcome for the victims of Domestic Violence and their families.
